# 2. Community/Government reports:

#### a. Government agencies and officers

Neal, librarian at Edendale branch library:

He gave an update on the myriad activities happening at the library.

## b. Community Organizations

Sally, representing the St. Athanasius Church:

She said that she is impressed with the transition of the neighborhood council. We are very interested in doing things with you. She mentioned that the church is feeding people in the park on Wednesday. This gives them hope.

(Note: Treasurer Mike Galano arrived at 7:03pm. There are now 14 voting Board members.)

## c. EPNC Chair Report

New Board member Han Lo has resigned, said Chair Tad Yenawine. His open seat will be contested at the next meeting.

Connie Acosta asked did he say why he was resigning? Yenawine replied no.

Separately, he told the audience that we are sitting in the room that we'll speak about later so take a look around.

(Note: Chief Information Officer Paul Bowers arrived at 7:08pm).

We will hold a special meeting for the bylaws, if necessary, said Yenawine.

# d. Treasurer Report

Treasurer Michael Galano said that we've spent \$15,000 so far this fiscal year. We will discuss 3 new grants tonight. He added that they will open a seat on the Budget and Finance Committee. Having a third member would help out, he said. Come to next Budget and Finance Committee meeting. We'll announce the seat.

#### e. Committee Chair and liaison reports

Ida Talalla, Arts and Ageing and Parks Committee: We've been meeting at the Echo Park branch library and the Edendale branch library. We've made progress on identifying resources.

Connie Acosta, Co-Chair of the Planning and Land Use Committee: Last week we had a successful town hall regarding the Mohawk collective.

Jeffrey Kontorovsky, Public Safety Committee: Robert Delario is the new Los Angeles Police Department Senior Lead Officer for the Rampart Division. He is very motivated. We had good conversations with him. Yenawine added that he seemed like a really good guy. We are looking forward to working with him.

Luiza Padilla-Mavropoulos said that there will be a farmers market in April. There is a sign-up sheet for Board members. She added that on April 9 we are sponsoring a faire for the Echo Park Recreation Center. There is a sign up sheet for that too.

Richard Courtney, Dodgers Committee: There will be a traffic study meeting tomorrow with the Dodgers and a traffic engineer. April 3 is opening day. There will be a hotline for any problems that day.

Yenawine told the audience to call 311 for any City problems that you have.

Vice Chair Darcy Harris, Bylaws Committee: The Committee met 4 times. We'll hopefully look at a package all together.

Andy Griggs, Alliance of River Committees: He attended the Committee meeting last night. There is a new Department of Water and Power customer bill of rigthts. Consumers are receiving cheques now for billing errors from last year.

There was also a discussion of the purchase of Taylor Yard. They are seeking the participation of our neighborhood council. There could be a town hall gathering about this. They are asking for a \$100 contribution.

There was also a presentation about the Budget Advocate. They have released a Budget White Paper. They are asking neighborhood councils to weigh in on this and pressure City Hall.

Regarding a Council District 1 debate, he added that several groups there said they'd like to cosponsor it.

Cheryl Ortega, Schools and Libraries Committee: They discussed a letter to City officials thanking them for their letter of safe haven for immigrants. However, Los Angeles County Sheriff Jim O'Donnell has changed his position since then. We want to send a letter to express our disappointment.

Paul Bowers said we are looking for new Board members to penetrate into neighborhoods that don't have representation.

Juan Fregoso, Field Deputy for Council Member Mitch O'Farrell, Council District 13 (CD13), (213) 207-3015, juan.fregoso@lacity.org:

He spoke about the Dodgers and street parking restrictions for their Opening Day. Parking will be limited to two hours. They will be

posted. They are meant to address some of the issues regarding people who've spent the day at bars.

Regarding City Trees in areas with lots of concrete, he asked the audience to contact him if you know of areas that could benefit (around buildings without shade). We'll contract out the watering. That had been an issue in the past.

We are working from the senior center to place 10-15 trees.

He spoke about murals. They are looking to revamp the extension stairs with lighting and by refurbishing the mural.

He recommends calling 311 and then following up with the Council District 13 office when you have an issue. That also goes for potholes. The City wants 72 hour turn around for pothole requests.

## 3. Public Comment on Non-Agenda Items

Alejandra Campoverdi, Candidate for Congress on April 4, www.alexandracampoverdi.com, @acampoverdi (Twitter):

She said that she was raised by an immigrant single mother. She is a Harvard graduate who has worked with the Obama Administration. She understands issues. She's worked in media. This community is where I come from. She hopes to have your support.

Lisa:

She said she is a recipient of meals on wheels. That charges about \$2.25 per meals. It's a very significant program. They also provide food for pets.

Thomas Devoe, the first chair of the neighborhood council:

He introduced himself and said that he is an attorney.

Jessica Salans, former candidate for the Council District 13 Election, Jessica @GroundGameLA.org, www.facebook.com/groundgamela

She now represents Ground Game LA (<a href="www.groundgamela.org">www.groundgamela.org</a>, @groundgamela) a group that aims to build hyper local relationships within the community. We work on issue based campaigns. We're connecting with organizations and with nonprofits in the area to connect

them with the community. That includes the neighborhood council. The group will be part of the Congress of Neighborhood Councils at City Hall in September. They want \$500 to \$1000 for the Congress.

Marcie Rose, Glassell Park Neighborhood Council:

She is concerned about a bill to prevent people from renting rooms in their homes. I don't appreciate that the City is suggesting that they have control over what I do in my home. She also runs a home business that the City has issue with.

She is a member of the Glassell Park Neighborhood Council. They have chosen to say to the City to keep out of her business.

Sally, St. Athanasius Church:

We're social activists. We are a sanctuary church to provide immigrants with help.

We have a sanctuary task force. We have ongoing workshops that allow immigrants to meet with attorneys. We want to help immigrants with child care and food, temporary housing, and local schools to provide resources for immigrants.

#### 7-11 Owner:

On April 29, 8:30am -11am, we will host "Coffee With A Cop" at our store. We're located at the Glendale and Berkeley location, he said.

#### 4. Selection of Board member to fill vacancy of District One Seat

Daniel Heimpel is the only candidate.

Ida Talalla said we don't know him.

Daniel Heimpel said that he lives in District 1. His political feelings were inspired by the shock of the Trump election. He has worked with the neighborhood council with small important issues regarding immigrant rights. He has worked as journalist and with nonprofits for years. He wants to work with the neighborhood council and with City officials. He said that he would love to be a part of the neighborhood council.

Cheryl Ortega added that Heimpel is member of the Schools and Libraries Committee. I whole heartedly support him, she said.

Luiza Padilla-Mavropoulous commented that from what I've heard about you, I'm very impressed. Treasurer Michael Galano concurred.

Jim Brown asked what's your nonprofit? Fostering Media Connections, replied Heimpel. We produce stories and distribute them to mainstream news sites.

Bowers said that he wants to get the word out about a big settlement about dangerous sidewalks. The more people who submit, the higher priority this will receive. There could be a separate committee formed. We want to identify the most dangerous places. Always submit this to the 311 app.

Andy Griggs commented that because of the settlement, there is discussion about outreach to the disability committees. There are events that are not accessible. Not many people attend meetings. Maybe have the Outreach Committee have a forum or town hall about this?

Padilla-Mavropoulos said to be aware that we have many events coming up. None of them were accessible last year. She'd like to see something that addresses that.

Ida Talalla mentioned the crosswalks around Glendale and Montana, Alvarado and Glendale. Some of these are Caltrans' responsibility. Caltrans has failed.

d. Discussion and/or possible action requesting \$200 for public works literature and materials including My311 LA for promotion and distribution in the community.

Talalla said I object to Mike Jolly's hand gesture to try to move the meeting along.

Acosta noted that the driveway is 25 ft from a school entrance. That's very close.

Harris made the motion. Richard Courtney seconded.

Geaga-Rosenthal had questions regarding the hours when alcohol is to be served. Harris answered them.

  - a. [Outreach 3-0-0] Approve and Send letter drafted by Daniel Heimpel and edited by Outreach Committee asking Mayor Eric Garcetti to name Los Angeles a Sanctuary City.

Padilla-Mavropoulos read the letter but not in its entirety as Yenawine objected with the understanding that everyone had a copy. They did not so Padilla-Mavropolous passed them out.).

Geaga-Rosenthal made the motion. Ortega seconded.

A Man thanked the neighborhood council for taking steps to push the Mayor to make Los Angeles a sanctuary city. There was applause.

Daniel Heimpel noted that Attorney General Jeff Sessions said people will get their money back. He wants this added to the letter referencing Sessions' tough talk.

(Note: Michael Galano returned to the room at 7:59pm.)

Harris said that this is a great idea. Mayor Garcetti has since issued a stronger directive. It's 5 pages. We should look at this new executive directive more and tailor the letter to that. Yenawine seconded and called for a postponement.

Acosta noted that the Los Angeles Times said that California is the greatest economy. We ship 99% of our food to other states. They are dependent on our undocumented workers.

Bowers referred to the sanctuary city definition by Mayor Garcetti.

Griggs said yes, we must be careful. He made a motion to refer the issue back to committee. Yenawine said this is an amendment. Refer this back to the Outreach Committee.

Heimpel asked is there an inter-meeting mechanism to deal with this?

Michael Galano offered a suggestion but Yenawine said it was too broad. There is no immediate deadline, he added.

Galano made a motion to not talk about this.

David Rockello said this is a great idea!

Padilla-Mavropoulos said that the first Echo Park Farmers Market Booth will be staffed April 7.

d. [Outreach 3-0-0] Outreach submits for the Board's consideration three design proposals, as requested by the council, for the EPNC logo redesign. Materials showing designs to be submitted during BOG meeting (The Old Design, The New Design, and a Third Option).

Dominic said the third option is new. At the Council District 1 Forum at the Sotomayor Academy, he sat halfway back. Only one of them could be easily read from that distance (the artichoke).

He favors the third option because it is something from the neighborhood.

Rockello asked please bring us back to chili and the lotus. Johnmichael Hull did a great job. That lotus is iconic. Others have used it in their promotion of Echo Park. Don't throw out the baby with the bath water.

A Man said I agree with what he said. He's involved in the Lotus Festival. Echo Park is so diverse. We must not lose the core of what the community was.

Ida Talalla said there are two designs there (1,2). In terms of tradition. #2 is the one that people recognize. However, she likes #1 (artichoke).

Michael Galano asked is it possible to get some white in there for differentiation? Dominic commented that it would definitely be a two tone two color logo. Mike Jolly suggested reversing colors.

Yenawine noted that the third design has clear lettering that people can see. Dominic added that this is something specifically from the neighborhood. Jolly said that branding is important.

Padilla-Mavropoulos said we've had so much taken from our community yet so many people remember the traditional Echo Park. She didn't like that people asked whether the design was an artichoke or an asparagus. We've lost a lot of tradition. Please keep our traditional logo with the red chili peppers. (design #2)

Richard Courtney said I agree with Padilla-Mavropoulos. However, branding is so important. In a room with 500 people, the only banner that was clear was ours.

Jim Brown said it's absurd that we're spending so much time on this. I'm embarrassed to be a part of this. However, I think #2 is the most definitive of these.

Geaga-Rosenthal said that from a sentimental perspective (she was part of the founding Echo Park Neighborhood Council Board in 2002), she likes #2.

Griggs said that design #1 stood out at that meeting was because of the color. So if there was color in #2, it would also stand out. Galano commented that that would that leave us in logo limbo.

Yenawine said that if we agree in concept on one design, we can look at more versions of that. Ortega commented that this community is in so much flux. Bowers said that the #1 design doesn't have to have the lettering where it is. You can put that to the side. You can encircle where the artichoke is. He said that he favors the original logo.

A Man asked can we have copies of what you're looking at? You are the only ones with copies.

Harris suggested to take the logo and use a new font. There is color. Acosta commented that in designs #1 and #2, the circle seems isolated. They are not integrated. For #2, you could move the lettering down a bit.

Talalla said that the second design is the lotus on the lake. The crest on the back misrepresents the lotus. She likes Acosta's idea.

Galano made a motion to pass this back to the Outreach Committee with the second design as having the most teeth. Geaga-Rosenthal seconded. Heimpel said when they come back, use the second design.

Yenawine offered an alternate motion: this include Galano's motion and authorizes the use of this design on business cards right now. He likes the clarity of placing words to the side. This would look good on business cards if we had a clear image. Jolly said to have Echo Park follow our design.

Yenawine said that he will vote against his own motion.

We had some business cards printed prematurely with the wrong logo. Yenawine is asking people to vote no.

# 10. [BFC] Discussion and possible Action on the following

a. [Outreach 3-0-0] Discussion and possible action re: approving Up To \$1,800 for possible location costs, food costs, beverage costs, and flyer costs to host a CD1 Runoff Election Town Hall with the remaining candidates Gil Cedillo and Joe Bray-Ali. The Town Hall will be held in District 5 of the EPNC map, at a location TBD, or somewhere also suitable within the Echo Park boundaries. The Date of the Town Hall is TBD dependent on the candidates' and location schedules. Upon approval, Outreach will engage with other neighborhood councils to seek financial and staffing assistance and participation, in order to lessen our financial obligation.

Galano said the total budget for this event is \$1,600 but you're being asked by the Outreach Committee to approve \$1,800 in case other neighborhood councils can't handle this. The Budget and Finance Committee recommended approval of \$750. We weren't sure how many neighborhood councils would be involved. Potentially there could 4-5 of them participating.

Acosta wants to amend the motion to \$400. Jolly wants to amend it to zero. Acosta and Kontorovsky seconded Jolly's motion. Harris said that 6-7 other neighborhood councils are interested in cosponsoring the event.

Candidate Jo Bray Ali can't possibly without this, said David Rockello. The election date is May 15. Spend the money, he urged.

Dominic said they won't pay for this themselves as Jolly suggests. He added that it's difficult to get Council Member Gil Cedillo to attend. This is standard practice. The original \$1,800 was for us to pay for the entire event without help from other neighborhood councils. We do need to pony up.

Marcie Rose, a Glassell Park Neighborhood Council Board Member, said that she would talk to them.

Ortega asked what actually determines the \$1,800 amount?

Dominic said that the cost of the last one for CD13 was \$1,300 with total budget of \$2,400. There were more than two candidates involved with several neighborhood councils involved, said Yenawine. This would be a good public service, he added.

Griggs said this is very important. Galano noted that we have \$5,000 in budget for events. We have a good amount of money for this kind of thing. Budget and Finance Committee meetings are where we decide these things.

Acosta said that she wants to make motion for \$400. Council Member Gil Cedillo is head of the Citywide Housing Committee so this is very important.

Padilla-Mavropoulos said that people are upset about the amount of money. We didn't have a high turnout at the last election. If we can make a difference, we should do this. If anyone can give a little guy a hand, Cedillo won't go out and do it.

Jolly said this is impotant. If we put money towards this, it's important for other neighborhood councils to do so too. Other neighborhood councils must pitch in.

Acosta suggested to donate a maximum of \$400. Yenawine said that he wants to postpone this if we can't come to consensus. Acosta said that at past events, she saw lots of food go to waste.

Talalla said that when you have candidates talking, let's use some of that money towards buying equipment.

Courtney said that at the last town hall, we were trying to rebrand and become legitimate neighborhood council. This is a great way to do so. We can rebrand. We have to be responsible for what's going on. Harris said that she helped coordinate the Council District 13 Forum. We spent \$2400. The last one took 3 months to organize. If we want to make it happen, we must have the flexibility to get started now. It would be great to get this done.

Brown said let's vote on the original amount. Griggs agreed. Ortega wants a postponement. Yenawine said there is another amendment for \$1,800.

Rockello urged to spend the money. A Man said it's better outreach than anything I've heard in the last two meetings.

Acosta said we should do the whole \$5000. That amount should be good. Fernandez seconded.

Paul Bowers recused himself.

Yenawine said this is the room that we are talking about. We would have 24 hour access. We could receive mail here. For \$1,300 it offsets about \$450 in expenses a month right now. It's great for committee meetings. There is air conditioning. There is a possibility of finding a community partner to share expense. Courtney seconded.

A Woman said I think it's a lot of your yearly budget. Also, parking is a problem. A Man asked what about other committees?

Sally said we have lots of parking at the St. Athanasius Church, which would be a great location for you. What is your need? Yenawine said small, about 200 sq ft. She said she'll ask tomorrow.

A Man expressed concern that this would be 1/3 of of the annual budget. Not a lot of people attend meetings. Rockello said I said no to this, the long term contract. This might be the right location but there are other possibilities.

Talalla commented we talk about having community groups here. Do we have a commitment? Can we charge them enough? Galano said we have to come up with creative ways to do that.

Yenawine said I have an email into the Department of Neighborhood Empowerment (DONE) asking whether people can donate to the church for us? We don't know yet. We're already spending \$450 per month. Iit's a huge chunk of our budget but we can find ways to offset it.

Acosta said she had a concern about the bylaws but she can't find the issue now. She said that she is worried that we would be violating our bylaws. Yenawine said that's not true according to DONE. Feel free to abstain from voting, he suggested.

Kontorovsky said this is a perfect space. Padilla-Mavropoulos asked about ideas for charging people to use the facilities.

Yenawine said we can't charge anyone anything. We can't accept donations.

Harris said that next year, people can find creative solutions. The Executive Committee spent a lot of time on this. It's frustrating that this is what I have to spend my time on. Right now, no one knows where our meetings are. Having an office in same space would make things so much easier.

Yenawine said we have stuff in storage that we don't use. This would consolidate everything in one place.

DONE representative Thomas Soong said that his colleague Jeff Brill is working on ways to deal with this.

Jim Brown said this is a great space but an unreasonable expense. Geaga-Rosenthal noted that the offset would be \$850 times 12 months. Griggs expressed his concern. I love this space. But it's not acceptable because of parking. I'd like to see a one year cap for this in order for me to vote for this. He recommends a commitment of 6 months. He will help to negotiate.

Bowers said that's a great offer. This will allow us to really do our work. It's too hard right now to find locations. This could be a game changer. The alternative would be a struggle.

Ortega said we can possibly find cheaper space. What if we vote yes now and Sally finds out tomorrow about St. Athanasius?

Yenawine said this allows us to begin negotiations. If we negotiate with Sally's church, we can do this or not. If we don't approve it, we can't do it.

This is a wonderful room but parking is an issue. It's not safe to walk around here, said a Woman. Yenawine conceded that there are definitely draw backs to this space but it is ADA (Americans With Disabilities Act) approved. Talalla asked if we go to St. Athanasius Church instead of here, what about storage?

Yenawine proposed an alternative motion. Take out the words "portion of the bottom floor of Echo Park Church" and insert "portion of space". Jim Brown seconded.

  - a. Bylaws, Article III, §2 to set the boundary between District 5 and District 6 at Glendale Blvd [BSR 2-13-17 5-0-0; reconsidered 3-21-17 3-1-1]

Yenawine said that a Bonnie Brae boundary makes more sense but Glendale Boulevard is where most people feel there would be less resistance.

Geaga-Rosenthal made the motion. Kontorovsky seconded. They are both District 5 representatives.

David Rugal spoke in Spanish with an English translation. He said that he lives at Temple and Belmont. He is concerned about injustice. We Latinos are 60% of the population of that area. Filipinos are less at 40%. We Latinos did not participate. We all

pay taxes. We need to be included in District 6. He then continued in English: It's unfair. We want some seats. We have a right to participate in our community. He wants the dividing line at Bonnie Brae.

A Woman spoke in Spanish with translation. She said she wants the boundary on Bonnie Brae or Alvarado. The area is mostly Latino. She's lived there for over 40 years.

Carmen Medina asked why are we making this an issue? The neighborhood council should represent the boundaries of the neighborhood council. Look at the map. Pulling it back does a disservice. Stick with Alvarado.

Rockello reminded that the Temple-Beaudry area was created in 2002. It's District 5. District 6 is Historical Filipino Town. Having a district with two different council members makes no sense. A woman expressed objection.

Margarita Fernandez said that she wants the boundary to be Bonnie Brae. Acosta seconded.

Kontorovsky said I agree with the Bylaws decision.

Mavropoulos said traditionally the boundary was Bonnie Brae. It became an issue when the two sides were not sharing money equally. She said that she wants the 5<sup>th</sup> district to get the appropriate amount of money. She is in favor of amendment.

Jim Brown said to keep things as they are. Geaga-Rosenthal said that a statement of the Bonnie Brae area population is arbitrary. We would need data. Yenawine said that according to data, 15% of Historic Filipino Town is Filipino.

Gaega-Rosenthal said that District 5 has a certain population. The Glendale boundary is part of the City's process. She is supporting the Glendale boundary for historical and justice reasons.

Bowers said that he favors the Glendale Boulevard boundary. He wants to create fair representation. He wants a main street as a boundary. He wants District 6 to be smaller to create more power for people in that area.

Acosta said that historic Filipino town starts at Hoover Street. We should go by terrain, not by population. She wants the boundary to be Bonnie Brae.

Talalla said this issue has been festering for years without reconciliation. Bonnie Brae is the place to make it fair and equitable.

Yenawine said the eastern part of District 5 often underserved. All of district 5 is frequently underserved on this Board. That's a huge issue. This is an attempt at reparations. He supports the Glendale Boulevard boundary. If we don't agree on a boundary now, we will need a special meeting. Padilla-Mavropoulos suggested to have a town hall meeting.

Yenawine reminded them that there is a motion on the floor, a motion to amend the boundary to Bonnie Brae (from Glendale Boulevard).

Jim Brown said that four years is too long. Ortega said that there has been continuity. Bowers said I'm conflicted. He has doubts that he would want to serve four years.

Harris commented that many people will drop out no matter what but this would allow mentoring and continuity versus paralysis. When you are not up for elections, we must have an Elections Committee with people who are not running.

Fernandez said that 4 years for volunteers is too much. People have been dropping out. We must have term limits.

Yenawine said I've been through one board transition. None of funding items left over were dealt with. All that money went back to the City. Regarding concerns abou serving for a 4-year term, he said you don't have to do all four years. There can be graceful process of recruiting new members. The point is to make the board in service to the community. Term limits amendments would be fine with me. He favors this as written.

Talalla said a 4-year deal is bad. It doesn't give the community a chance. This board went through exhaustive measures, intervention that should have happened with the prior Board. Yenawine interrupted her, asking what is the point?

Geaga-Rosenthal said I support this. The other changes address how to remove Board members. She likes the whole package of Bylaws changes.

Yenawine said that we will need 11 votes in order to make this change.
