2. Community/Government reports:

a. Government agencies and officers

Barbara Ringuette, Budget Advocate Region 7:

She encouraged stakeholders to elect budget representatives, and reminded the audience to come to Budget Day, Saturday, June 24th. Breakfast is included. She listed the responsibilities of budget advocates: attend meetings at least twice a month at City Hall, along with other meetings. They meet with managers, chief financial officers, and deputies. More information is available at http://ncbala.com.

Rob Solorio, Police Officer: He detailed his territory within the Echo Park area, and reminded everyone that parking crimes are prevalent, and to remember to lock your cars and hide your valuable property.

Andrew Said, Neighborhood Prosecutor: No updates.

Dina Fletey, Police Officer: She detailed her territory, and brought a flyer with her information. There's a lot of crime happening north of Sunset, especially break-ins and robberies. Most importantly, these crimes are often happening from midnight to 6 in the morning, so burglaries are happening while residents are home, she added. A lot of stolen property ends up in homeless encampments, and unfortunately, because residents are not reporting the stolen property, it is difficult to tie the property to the thieves. Luckily, violent crimes are way down, especially compared to Highland Park.

This led to a question about whether dogs were a good deterrent for break-ins. She responded that they are excellent deterrents, and reminded everyone to listen to your dogs if they sound alarmed.

A stakeholder asked everyone to be vigilant regarding gas leaks and their health issues. She responded that it is a building and safety violation, and anyone can file a complaint with the relevant department.

John Darnell, Project Coordinator for the Neighborhood Council:

He introduced himself, and clarified that his role is as a vehicle for neighborhood councils to affect change within the larger political structure. He is happy to help any way he can. A survey is going out, and taking it can help the city know about what issues are important to the communities. There is an event for Homelessness Civic U on May 31st, and it is open to the public. He also added that they are working on changing the website to make it more useful and easy to use.

b. Community Organizations

Joelle Dobrow, Representative from the Library:

She had a proposal she wanted to make, asking the Board to form a committee and support the production and development of a community event for the dedication ceremony for the completion of the new lake additions. She would like the Board to supply members of the executive and finance committees in order to better represent parks, schools, libraries, and public works. Also, September 8th and 9th are tentative dates for an event in which backpacks, binoculars, and field guides will be supplied for people to bird watch near the lake.

c. EPNC Chair Report

Tad Yenawine, Chair:

He started by discussing the new office space, which will be available after June 31st, along with a regular meeting space for both EPNC and EPIA. He added that they are working on having consistent professional translators for every meeting. Starting next meeting, the Board will be operating under new bylaws that will hopefully be approved by DONE soon. Due to this, new officer positions will be created: a vice-treasurer and a secretary.

This led to a question about whether the secretary or the treasurer would be the card-holder. Yenawine responded that there is only one card holder, and it was not specified in the bylaws.

He added that they also voted for mandatory participation in committees. They will expect every member on the Board to sit on a committee. He also stressed the importance of supporting committees' recommendation and reports, as well as the importance of supporting the treasurer's recommendations on budget spending.

In February, the Board will open funding applications for ongoing organizations.

Cheryl Ortega added that she wants to prioritize organizations within the Board's boundaries, and are Echo Park-based.

Ida Talalla added that the Board needs to promote deadlines so that organizations are aware of their funding schedules.

Paul Bowers commented on the importance of funding outreach towards underserved communities, such as the newly-formed 5th and 6th district communities. It is not necessary to proportion the budget towards community improvement projects.

Yenawine reminded the Board that the purpose of funding organizations such as LA Theater Academy is to create relationships and raise awareness of the Neighborhood Council organizations.

Talalla brought up the issue that the community may be confused as to when meetings are being held. There should be a schedule for when meetings are to be held that is publically accessible by the first of the month.

Yenawine clarified that the space in the Echo Park United Methodist church is available every Tuesday of the month. Committees should be meeting on the first Tuesday, possibly with multiple meetings in one night, with another committee meeting on the second Tuesday of the month.

Ortega added that she would like to request that when organizations go to the executive committee for requests, that they are referred to the appropriate committee.

Yenawine clarified that the new bylaws should satisfactorily clarify that.

Darcy Harris added that she would like to see committees meet in the first two weeks, so that reports are ready for the Board of Governors meeting later on in the month.

Connie Acosta asked why Yenawine mentioned EPIA's meeting schedule coinciding with the EPNC. Yenawine responded that the EPIA and Neighborhood Council orginizations diverged years ago, and that he is attempting to bring them back together as co-existing organizations. EPIA was losing their space, so he offered an alternative.

Acosta asked whether this was permissible by DONE. Yenawine answered that they can offer the space to any community members so long as they do not charge.

Joelle asked whether it would be possible for her organization to use the space. Yenawine responded that it would be possible after June 1st.

Acosta asked if the executive committee would be telling committees when to meet. Yenawine responded that it would be possible, but he would rather see committees making their own schedules to their convenience.

d. Treasurer Report

Michael Galano, Treasurer, went through a series of handouts detailing the budget. \$42,000 is the total budget for EPNC, with \$19,500 in NPGs approved by the Board and submitted to DONE for approval. \$12,500 of that, has already been approved by DONE. There is \$2991.87 left in the budget. The plan was to write four NPGs for \$2500. He added that the priority has always been for non-profit organizations and schools.

Yenawine asked if the remaining money in the budget included the NPGs on the agenda. Galano clarified that the remaining budget included the NPG deductions except for the NPGs on the agenda for tonight.

Harris asked if it included office equipment. Galano responded that it would come from the \$2991.87.

Galano added that the end of the fiscal year is June 30th, but the last time he can send checks is during the first week of June.

Michael Galano left at 8:14 pm.

- 3. Public Comment on Non-Agenda Items, one minute per speaker

David Rockello: I want all of you to come to Neighborhood Council Congress. I also want to talk about the Echo Park parade on the second Saturday of December. Likewise, a reminder that Lotus Festival is coming up soon. Neighborhood council congress. I want you to come. I want to talk about echo park parade. Second saturday of December. Lotus festival is coming up.

Jorge Castaneda: I'm passing around a draft of a proposed motion that I'm talking to all councils. The content is the general plan updates. These discussions have gone on behind closed doors for months, there are about 5 neighborhoods, their community plan has been clustered into one mega plan. We spoke with their councils and they hadn't heard anything. We want these neighborhoods to talk to city council and demand transparency. We've already had some neighborhood councils submit letters. The second thing I'll say is we are hosting free workshops throughout the city at the end of june, beginning of July, how to contest a questionable MER, so that the community can have their input woven into these plans.

Andy Griggs asked if he had a website. Jorge responded that they had one for "Yes on S" but have to retool it to focus on this new campaign.

Acosta mentioned that she had heard that the community plans are being done by the state, and will be presented to communities for feedback later on in the process. Jorge responded that he wanted to see neighborhood involvement regardless.
